If a company is identified as a Special Company which refers to company classified as under designated categories including but not limited to the following categories after company search:

- Company with 3 or more layers in its ownership / controlling structure; or
- Company engaging in money / currency exchange, money transfer or remittance agent services; or
- The account to be opened by the company being a trust account.
- Amendment of Authorized Signer(s) or Company Chop(s)
- 4. Dormant Account Reactivation Fee
- 5. Monthly Maintenance Fee
 - Applies if the average daily "Total Relationship Value" (TRV*) balance of an account is lower than HKD100,000 or equivalent during the relevant calendar month

*TRV balance is calculated starting from the opening date of Current Account / Savings Account / Business i-Account and includes deposit balance of all deposit accounts and latest market value of relevant investment accounts including fund / bonds / notes / FX margin trading / securities.
