- 7. The Bank may at any time and without prior notice set off or transfer any monies standing to the credit of the Cardholder's and /or the Company's Bank Accounts of whatever description towards discharge of all sums due to the Bank in connection with the use of the Card.
- 8. All liabilities of the Company and the nominated Cardholder(s) under the said Terms and Conditions shall be joint and several.
- Notwithstanding any term to the contrary, the Bank reserves the over-riding right to repayment ON DEMAND.
- 10. Cardholder shall in conjunction with the Company terminate the card service before the effective date if any amendments to the terms and conditions proposed by the Bank are not accepted.
- 11. The Card shall not be used for any unlawful purposes.
