If there is no sufficient available fund in your card / bank account applicable to your Debit Card in the Supported Currency relevant to settle the full amount of your Overseas ATM Cash Withdrawal or In-store / Online Purchase (as the case may be), the Bank has the right (but shall not be obliged) to convert the difference between the relevant transaction / withdrawal amount and the available balance in the relevant transaction currency in your relevant card / bank account ("Transaction Difference") to and debited in Hong Kong dollar from your relevant card / bank account at the Bank's prevailing exchange rate without prior notice to you. If there are sufficient available funds in Hong Kong dollar in your relevant card / bank account to settle the Transaction Difference, the Bank will debit the Hong Kong dollar and the available remaining balance in that relevant Supported Currency from such account to settle the Transaction Difference and the relevant transaction / withdrawal amount accordingly. If there is no sufficient available fund in Hong Kong dollar in such account to settle the Transaction Difference, then the Bank has the right to reject the relevant transaction / withdrawal.
- 4. If the Bank effects the Auto FX and authorizes a transaction / withdrawal which a customer has made but such transaction / withdrawal is subsequently cancelled or not settled, the currency exchange effected through the Auto FX will not be reversed.
- 5. The exchange rate applicable to each transaction / withdrawal in non-supported foreign currency includes (i) the exchange rate determined by Mastercard on the date on which the transaction / withdrawal is processed and (ii) a transaction fee of 1.95% on the relevant transaction / withdrawal amount (transaction fee(s) charged by Mastercard to the Bank inclusive (if applicable)).

Note: The Supported Currencies of Dah Sing Multi-Currency Mastercard® Debit Card are HKD, AUD, CAD, CHF, EUR, GBP, JPY, NZD, RMB, SGD, USD.

In the event of any discrepancy or dispute as to the meaning of any provision, the English text shall prevail.

For the service charges in HKD equivalent, the Bank will levy the fee according to an exchange rate set by the Bank. All out-of-pocket expenses are for account of clients.
